## Re: Preventing the exploitation of migrant workers

We, the undersigned organisations, undertake to achieve access to justice for migrant workers in Australia and hold serious concerns about the ongoing exploitation of our client base.

Prime Minister Morrison has pledged to create 1.3 million jobs over 5 years. Given Australia's closed borders during the COVID-19 pandemic, economists have indicated that immigration will be critical to reaching such targets.<sup>1</sup>

A recent Senate Committee<sup>2</sup> recognised that wage theft and exploitation of migrant workers is deliberate and systematic. We see this every day: underpayment of entitlements is our clients' single-most common employment-related problem. Many migrant workers simply accept wage theft as the status quo.

"My visa is my main concern: 100%. I'm not going to risk my visa to chase my wages if there is only a chance or a hope that the government will protect me."— **Hayma, international student and cleaner.** 

Migrant workers tell us they are unwilling to risk their visas to pursue unpaid wages and entitlements through a complicated and lengthy process with an uncertain outcome. Many of our clients are simply too scared to act. Unscrupulous employers target and exploit this vulnerability for commercial gain, allowing them to undercut businesses doing the right thing.

"I've been working in Australia for almost 5 years. I've paid my taxes and abided by the law. I worked hard to make Australia my home. Work owes me 10 weeks of annual leave but they cannot afford to pay me. Who is going to help me?" – **Tristan, skilled sponsored worker and chef.** 

These workers often struggle to recover their entitlements through the courts, and if their employer's business fails, they are ineligible for the Australian government's Fair Entitlement Guarantee.

The undersigned are employment law specialists and organisations supporting migrant workers. We are in a unique position to comment upon the legal structures that lead to exploitation and the law reform needed to effectively protect some of the most vulnerable workers in the community.

In recent years, our services were consulted in numerous government inquiries and reviews into 'wage theft' and migrant worker exploitation, both at a federal and state level. These inquiries made significant and wide-ranging recommendations for reform. There is widespread accord on what must be done to end the exploitation of migrant workers.

What we now need is government action.

We ask you to start the process of ending the exploitation of migrant workers. Please indicate your support for three key reforms recommended by Senate Committees to reduce the exploitation of migrant workers:

- 1) Allow migrant workers to act against exploitative employers by providing effective visa protections to whistle-blowers that report exploitation or wage theft to the Fair Work Ombudsman and extend these protections to exploitation and wage theft claims progressed through the courts.<sup>3</sup>
- 2) implementing an efficient, accessible, and inexpensive dispute resolution mechanism for workers to promptly recover all unpaid entitlements and superannuation.<sup>4</sup>
- 3) Extend the Fair Entitlements Guarantee to all employees, including those on temporary visas.<sup>5</sup>

The signatories of this letter are happy to work with you to achieve the implementation of these recommendations and change more broadly.

We request that you make a pre-election commitment to the above reforms by 11 May 2022.
